CONSUL GENERAL OF JAPAN IN DETROIT INTRODUCES HONORARY CONSUL OF JAPAN FOR OHIO DAVID COOK

WHAT: On Wednesday, June 28 from 6:30 p.m. to 8:30 p.m., Consul General Mitsuhiro Wada will host a reception to introduce Mr. David Cook as the Honorary Consul of Japan in Ohio. The event will take place in the lobby of the law firm of Vorys, Sater, Seymour and Pease LLP in Columbus.

Mr. Cook is a partner at the Columbus office of the law firm of Vorys, Sater, Seymour and Pease LLP. He specializes in immigration and naturalization law for businesses and individuals. Japan is the largest foreign investor in Ohio, with 482 Japanese facilities directly employing more than 73,400 people in the state. There are more than 2,300 university students and 1,300 K-12 students currently studying Japanese in Ohio's schools. In addition, there are sixteen active sister/friendship city relationships with Japan, and a sister state partnership with Saitama Prefecture dating back to 1990.
